A **Backyard Pools Weekly Maintenance Service Agreement** provides a comprehensive service for your pool by following a carefully planned routine that will keep your pool water sparkling, and your pool equipment operating properly throughout the season.

Our **Weekly Maintenance Service Agreement** provides the following services with each visit:

- Pool is hand vacuumed with our own equipment, surface skimmed, tiles brushed, and leaf baskets cleaned.
- Filter cleaned as required. (minimum once a month)
- Chlorine generator is inspected or chlorinator refilled.
- Pool heater checked for proper operation.
- Water tested and chemicals added if requested by homeowner.
Note: Homeowner's chemicals (Bioguard only) will be used if available, otherwise chemicals will be provided and charged accordingly. Will not use other chemical brands due to dosage rates and liabilities.
- Balancing chemicals will be charged monthly per pound if not available.
- Replenishment of your Bioguard chemicals will be charged monthly.
- Written report will be provided after each visit detailing:
Water testing results, chemicals that were added and any special requirements needed.
