Baker Pool & Spa carries and will maintain liability insurance and workmen's compensation as required by law. Due to conditions beyond our control, Baker Pool & Spa cannot accept responsibility or liability for the present or future condition of the owner's pool or equipment. Baker Pool & Spa does not accept responsibility for damage to the pool structure and piping by reason of the water table rising above the lowest point of the pool when the pool is empty or by reason of any earth or ground fill movement. This includes cracking and leaks resulting from pool flotation. No rain days for weekly maintenance plans.

Opening, closing and weekly maintenance plans may be cancelled by either party **only upon written notice at least ten (10) days prior to date on which service is to be discontinued.** Additional surcharges or fees may apply.
