All products provided under this Agreement shall be used without modification unless approved by the manufacture. Shipping costs shall be the responsibility of Racer. XMM does not guarantee delivery of Products by any certain date. Delivery of Products is subject to stock on hand. In the event XMM is out of stock, every effort will be made to receive Product/s in a timely manner. However, XMM assumes no liability for delivery of Products on any schedule. XMM encourages Racer to order early and to keep spares on hand.

Racer agrees to put forth his/her best efforts in each and every race entered and agrees to use XMM for the calendar year 2009 ("the Season"). Racer further agrees to: a) Adhere and keep in place for the duration of the Season not less than two XMM stickers on its Race equipment; Motorcycle, ATV, UTV, Watercraft, etc... b) Name XMM as a sponsor in all race entry forms, press releases, correspondence materials and interviews with the media when appropriate; c) Promote XMM and XMM products whenever possible by answering questions of race spectators, other racers or others interested in XMM. XMM shall furnish Racer with any stickers needed to fulfill Racer's sticker obligations hereunder.

Racer hereby grants to XMM and/or its advertising agents, at no additional cost therefor, total, unrestricted rights to promote and advertise, through any media of XMM's choosing, XMM's sponsorship relationship with Racer, Racer's use of XMM products, and/or Racer's accomplishments for the Season. These said advertising and promotional rights shall survive into perpetuity.

By signing this Agreement and/or using any XMM products Racer, and any other rider of Racer's equipment, including those not listed herein, agree, which agreement shall survive the closing of the Season, to release Xtreme Moto Madness from any and all liability pursuant to the use of said Products. Racer represents hereby that he/she will communicate such release of liability to any other riders of the Race equipment before allowing such other riders to ride any of the Race equipment. Racer further agrees to obtain from each such rider his or her written consent to such release of liability. Additionally, Racer agrees to defend and hold harmless XMM in the event of any litigation pursuant to the use by Racer, or any other rider of Racer's equipment, of the Products.

Racer acknowledges that XMM may provide and/or sell products that are not necessarily Department of Transportation (DOT) certified and for "Racing Only". If a racer has at any time during the season failed to comply with the terms & conditions hereto, XMM may terminate this agreement upon ten (10) days written notice, whereupon XMM shall have no further obligation to racer.

However in any event the provisions of hereinabove shall remain in full force & effect into perpetuity. If a racer does not fulfill his obligation to this contract, he/she shall be liable to reimburse XMM for any product, product discount or shipping costs XMM may have incurred during the race season for said racer.
