DFA Waiver, Release and Indemnity Agreement

The undersigned individual for himself or herself, his or her spouse and/or his or her children or ward, and their heirs, next of kin, executors, representatives, administrators, successors, and assigns (hereinafter collectively and individually referred to as the "Undersigned") who participate in Dirt Floor Arena (DFA) sponsored activities, events or programs at the Dirt Floor Arena Complex located at the Duluth/Proctor Fairgrounds, Municipalities, Counties, or other local governments in or through which the Event takes place or is conducted, agree to indemnify, save and hold harmless any person, volunteer, entity or sponsor connected with the Event, and their respective officers, directors, agents, employees and volunteers, and their heirs, next of kin, executors, representatives, administrators, successors, and assigns (hereinafter collectively referred to as the "Released Parties"). The Undersigned does hereby voluntarily and forever waive, release and discharge the Released Parties from any and all claims, actions, and/or liability of any type or kind (including, but not limited to, damages for personal injury) that the goods, services, participation, instruction in any way, or anything else connected with the Event, by or as a result of any action or inaction of the Released Parties, or other acts or omissions of any type or kind relating to the Event, regardless of wherever the Event is held. The Undersigned fully understands, acknowledges and agrees that by participating in the Event, there is a probability of accidental or other physical injury or death. Nonetheless, the Undersigned further agrees to assume the risk of personal injury or death, and any and all other risk or any loss or injury of any type or kind whatsoever to Undersigned, Undersigned's livestock or injury or loss by Undersigned to other livestock, including loss of use and any other indirect or consequential damages which the undersigned may suffer, resulting directly or indirectly, wholly or in part, from the Event, and further agrees to indemnify and hold harmless the Released Parties from any and all loss, cost or expense suffered, and claims, demands, actions, damages and judgments of any nature asserted against the Released Parties as a result of the Undersigned's participation in the Event. Under Minn. Stat. § 604A.12, the sponsor(s) of livestock activities are not liable for the injury or death of a participant, or a spectator in an unauthorized area arising from the inherent risk of livestock activities. Inherent risk means the dangers arising from the propensity of livestock to behave in unpredictable ways, including kicking, biting, spooking in response to sound, sudden movement, unfamiliar objects, persons and other animals. In the event any provision of this Waiver, Release and Indemnity Agreement is found invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall not be affected thereby and shall be enforced to the extent permitted by law.

The Undersigned has read and understands this Waiver, Release and Indemnity Agreement and by signing below, the Undersigned consents for Undersigned and/or Undersigned's household members to participate as DFA Member(s).
