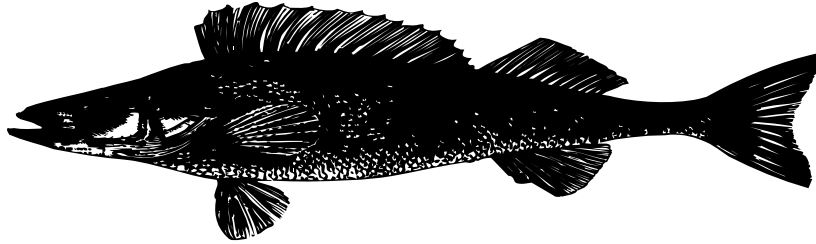

Synopsis of Rules

(Complete Rules Available Upon Request)

1. Entries close at 5:00am on Saturday September 11th, 2010.
2. All tournament waters will be off limits as 2pm on Friday September 10th, 2010.
3. Daily bag limit: 6 fish in possession, only 2 of which may be over 24".
4. Live and artificial bait will be allowed in accordance with Oregon Fishing Regulations.
5. Fishing area: Legal boundaries Lake Umatilla.
6. Use of an aerated livewell is required. No exceptions.
7. An 8 oz. penalty for each dead or poorly handled fish will be assessed before weight is determined.
8. No alcohol will be allowed in boats or contestants during tournament hours.
9. Boats will be inspected prior to launch each day. An official may stop and inspect contestant boats at any time.
10. The decision of the Tournament Director and Weighmaster shall be final in any and all questions.
