

Wide Open Co, Rangerware® and RhinoGear® Limited Warranty

Wide Open Co, RangerWare® and RhinoGear®, 19006 River Road, Grand Rapids MN 55744 provides the following LIMITED WARRANTY on its products to the purchaser of these products and to the person to whom such products are transferred during the duration of this warranty.

The warrantor's obligation shall be limited to repairing or replacing at the above address, any part or parts which shall within a one year period hereinafter to be returned to them with the transportation pre-paid and which upon examinations by Wide Open Co, Rangerware® and RhinoGear® shows to have been defective in quality or workmanship. This warranty shall NOT APPLY IF:

- The product has been altered, repaired or modified outside the warrantor's place of business in any way that would adversely affect its operation.
- The product has been subjected to misuse or damage while in the possession of the purchaser or was operated or used other than in accordance with the manufacturer's operating instructions.
- The product failure is attributed to damage which is the sole responsibility of the user.
- Gelcoat, gelcoat cracking, crazing or stress cracks. Gelcoat and/or stress cracks and crazing are specifically not considered defects in materials or workmanship. A stress or gelcoat crack is a crack in the gelcoat and/or skincoat (first layer of fiberglass). They are cosmetic, not structural in nature and may be located anywhere on the enclosure system. Or also fading, chalking, blistering, or discoloration of gelcoat or paint.
- The cosmetic surface coats of all our products are applied in strict adherence to the manufacturer's specified application recommendations. Wide Open Company, Rangerware® and RhinoGear® has no control over any materials supplied to Wide Open Company, Rangerware® and RhinoGear® by our vendors. Wide Open Company, Rangerware® and RhinoGear® can only demand that the vendor meet our specified protective quality criteria.

The one year limited warranty shall commence with the date the product is sold to the purchaser by the dealer, or if this date cannot be established, the date the product was sold by Wide Open Co, Rangerware® and RhinoGear® to the distributor or dealer.

THE IMPAIRED WARRANTIES OF MERCHANTABILITY AND THE FITNESS FOR PARTICULAR PURPOSE ARE LIMITED TO THE DURATIONS OF THIS WARRANTY-ONE YEAR- AFTER SAID ONE YEAR Wide Open Co, Rangerware® and RhinoGear® EXPRESSLY DISCLAIMS ANY WARRANTY OR MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.

Purchase or other acceptance of the product by the claimant shall be on the condition and agreement that Wide Open Co, Rangerware® and RhinoGear® SHALL NOT BE LIABLE OR CONSEQUENTIAL DAMAGES OF ANY KIND.

Some states do not allow limitations on how long implied warranty lasts or do not allow the exclusion or limitations of incidental or consequential damages, so the above limitations may not apply to you.
