Rules

1. Must be signed up with tournament rewards to be eligible for Nitro, Tracker, Procraft Bonus Money (call for details).
2. Lie Detector will be given to winners at tournament director's discretion.
3. Money will be held until lie detector given if tournament director deems necessary.
4. Scoring system will be used top 6 out of 10 tournaments.
5. 1 in 3 - 30% will qualify for classic on points or fish 8 tournaments.
6. No substitute fishermen will be allowed. Must fish alone if partner cannot fish or start over as a new team.
7. Cannot fish without paying membership.
8. All fish released.
9. Spotted large mouth bass and smallmouth bass, five fish limit.
10. 1 in 5 places paid.
11. 18 years of age or accompanied by someone over 18.
12. \$125 entry fee classic - plus Big Fish.
13. Ties combined and split.
14. Short fish below 12" will be culled along with Big Fish.
15. 1 pound of dead fish penalty - no dead fish used for Big Fish.
16. Late return disqualified.
17. Only five fish in live well no culling at dock or weigh in.
18. Trail winner instant pay based on 8 tournaments fished (Best 8 tournaments).
19. Classic Lake off limits after drawing.
20. Lake off limits day of tournaments (Night Tournaments).
21. Classic Lake from previous year not available.
22. Second day of Classic, weights start over.
23. No alcohol during tournament hours.
24. 5 Bonus points Big Fish.
25. 5 Bonus points 1st Place.
26. Previous year Classic Winner and Angler of the Year automatically advance to Classic.
27. Amateurs only - No Touring Pros.
28. All contestants must wear a U.S. Coast Guard Approved life jacket while gas engine is on and a kill switch must be attached.

Tracker Nitro Big Bucks Buddy Trail Waiver and Release of Liability READ BEFORE SIGNING

In consideration of receiving a fishing membership or being allowed to participate in any way in the Tracker Nitro Big Bucks Buddy Trail, ("the Trail") related events and activities, the undersigned acknowledges, appreciates, and agrees that:

2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES** or others, and assume full responsibility for my participation, and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual, significant hazard during my presence or participation on the Trail, I will remove myself from participation and bring such to the attention of the nearest official immediately, and,
4. I, for myself and on behalf of me heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS Tracker Nitro Big Bucks Buddy Trail; and Sylacauga Marine & ATV, Inc.**, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("RELEASES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH**, or loss or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE**, and,

The undersigned expressly agrees that this Waiver and Release of Liability Agreement ("Agreement") is intended to be as broad and inclusive as permitted by the laws of the State of Alabama and that this Agreement shall be governed by and interpreted in accordance with the laws of the State of Alabama. The undersigned agrees that in the event that any clause or provision of this Agreement shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Agreement, which shall continue to be enforceable.
